We are well into the month of September; and wherever you look, you see signs that summer is over, and we are into the season of Autumn, although as of the date of this writing, the first day of Fall is still another week away. Our students are back in school, fall sports programs are in full swing, homeowners are busy preparing their homes and yards for the upcoming winter. Our farming communities are well into harvesting, and are keeping one eye on the sky, hoping and praying for sufficient dry weather to get the crops in. We've been fortunate, here in the south, that we've not yet had a killing frost on the fields and gardens, but that's only a matter of time. Every day we are grateful, indeed, for the blessings of an abundant harvest and the fruits of our gardens!

- Do you personally know someone who has fallen through the cracks of the system and is struggling?
- Are you aware of a potentially hazardous or life-threatening element in our environment that should be eliminated?
- Do you know of any other issues relating to social justice that should be addressed?

If yes, then there's a resolution sitting waiting for creation. Truly, I have a hard time believing that all of our members in Manitoba are absolutely satisfied with the status quo! If you or your Council is interested in writing a resolution, there are many resources available to you. Start with the National website – it contains a wealth of information. If you can't find what you're looking for, or if you'd like support or guidance, I encourage you to reach out to your Diocesan or Provincial Council; there are several people who would walk you through the process and guide you along every step. There's no magic; it might seem intimidating, but it's really not that difficult.

This past August, at the National Convention in Kelowna, one resolution was adopted: 2022.01 Enact Federal Legislation to Address Food Laws and Waste, gifted to us by Alberta-McKenzie Provincial Council. This resolution will appear in the fall issue of the League Magazine; watch for it, or search for it on the CWL website.

I look forward to working with many of you in this capacity, as we navigate through the many of these issues.
