

The Catholic Women's League Manítoba Probíncíal Councíl 71st Annual Convention June 9, 2019 ORAL REPORT Past President Faith Anderson

This is an election year for Manitoba Provincial Council and the process began in January 2019. Councils were gifted several years ago with a *Nominations and Elections Guidelines* binders for parish, diocesan and provincial councils. This has been a wonderful tool providing timelines, instructions and templates to use. Councils are encouraged to utilize this tool during their election process. Although I was part of the development of this document, this was my first time to use the tool. It made the process easy. (Show cover page of Nomination and Elections Guidelines for Parish Councils.)

Each year an *Elections Register* is prepared/updated by the recording secretary and in an election year provided to the Nomination and Elections Chairperson. An *Eligibility List* is created from the *Elections Register*, identifying any restrictions for each candidate (i.e. not eligible for standing committee – have served two terms, served two terms as treasurer). Personalized invitation letters to serve were emailed to current officers and eligible diocesan presidents. The president-elect was contacted to confirm her willingness to assume the office of president. A *Nomination Acceptance Letter, Acceptance Form* and *Resume of CWL Service Questionnaire* was sent to eligible members. Only at the parish council level can the Committee seek nominations for vacant positions. From the received Acceptance Forms, an *Eligibility List* with replies and *Acceptance List* is compiled. This list, along with the resumes and *Nomination Form* is forwarded to diocesan council presidents. The diocesan executives prayerfully discerned and reviewed the *Acceptance List*. Their nominations for the officer positions for a new provincial executive are the instructed vote that the diocesan president uses to vote during elections at provincial convention.

Archives are an important aspect of the past president's duties. The contents of your council's archives are a living testimony to the members and their accomplishments since receiving your charter with The Catholic Women's League of Canada. In a recent meeting with Manitoba Archives some of their recommendations were to: use paper clips instead of staples, file folders instead of binders, for newspaper clippings – keep original but make a photocopy to preserve the content and any photos should be labelled with event and include names. Please refer to the archives guidelines in the *National Manual of Policy and Procedure* for complete information on organizing your archives. Celebrate who you are and your accomplishments. When the archives are developed, they are easy to maintain.

Once in every term, the *Manual of Policy and Procedure* should be reviewed and updated. At province level an extensive review has been undertaken. Several hours was devoted to this process updating and incorporating adopted motions and including any necessary new policies. With the cooperation of the provincial executive a comprehensive document has been developed. The Manual of Policy and Procedure is a living document and with the fresh eyes of each new executive valuable additions and revisions will continue to be made. This is an important process at each level of the League in order to have a document defining policies for their councils.

In closing, I would encourage all past presidents to continue to mentor and provide guidance as required to members and their councils. Even though you are a past president you have an important role in the future of the League as it strategically plans to strengthen and grow for the next millennium.
